Impact of the Compacts of Free Association (COFA) on Guam (FY 2004 - FY 2017); Planning Information Program, Bureau of Statistics and Plans, Office of the Governor; Annually. The COFA Amendments Act of 2003 (P.L. 108-188), an agreement between the U.S. and the Federated States of Micronesia and the Republic of the Marshall Islands, and the COFA Act of 1985 (P.L. 99-658), an agreement between the U.S. and the Republic of Palau, authorized unrestricted immigration into the United States, its territories and possessions, enabling citizens of these island areas to enter into, lawfully engage in occupations, and establish residence as non-immigrants aliens. This report presents statistics on the cost of

It includes the Department of Defense obligations and expenditures related to the Guam Realignment and provides a listing of awarded contracts, grants, agreements, or other funding mechanisms made available towards the realignment. Detailed planning was also a product of interagency effort in which stakeholders throughout both territory of Guam and the federal government, most often in the form of territory and federal emergency support functions, worked with private sectors representative to address many of the of the challenges inherent in a catastrophic typhoon scenario. It presents demographic characteristics of Guam's homeless population including data on homelessness by age, ethnicity, households by village, homeless veterans, reasons for homelessness, and by disability.
