DETAILED INDUSTRIAL CLASSIFICATION

[1] AGRICULTURE, FORESTRY, AND FISHING

Includes Veterinary Services, Landscape & Horticultural Services, Fishing, Hunting and Trapping.

[2] CONSTRUCTION

Includes General Building Contractors, Heavy Construction and other Construction Related Services.

[3] MANUFACTURING

Includes Manufacturing Establishments on Guam.

[4] TRANSPORTATION AND PUBLIC UTILITIES

Includes all Transportation Related and Public Utility Services.

[5] WHOLESALE TRADE

Includes all Wholesale Trade Durable and Nondurable Goods Business Establishments.

[6] RETAIL TRADE

Includes General Merchandise Stores such as Department Stores, and Malls. Also includes Food Stores, Restaurants, Bakeries, Automotive Dealers and Service/Gas Stations, Apparel and Accessory Stores, Furniture, Electronics and Appliance Stores, Drug Stores/Pharmacies, Florist, Optical Shops, Book Stores, Sporting Goods and Bicycle Shops, Computer and Software Stores.

[7] FINANCE, INSURANCE AND REAL ESTATE

Includes Banking Institutions, Credit Unions, Foreign Banks and Branches, Security and Commodity Brokers, Insurance Carriers, and Real Estate.

[8] SERVICES

Personal Services: Includes Laundry and Dry Cleaning Garment Services, Photographic Studios, Beauty/Barber Shops, Funeral Service and Crematories.

Business Services: Includes Advertising, Credit Reporting and Collection, Mailing, Equipment Rental and Leasing Computer and Processing Services, Detective and Armored Car Services.

Auto Repair/Parking Services: Includes Automotive Rental, Paint & Body, and Auto Parking.

Other Services: Includes Electrical and Appliance Repair, Motion Picture and Video Tape Production Health Services, Legal Services, Educational Services, Social Services (Day Care, Elderly and other Residential Care), Engineering and Architectural Services, Accounting and Bookkeeping, and Business Consultation.

[9] RECREATION

Includes Water Sports, Theaters, Golf Course, Dinner Shows, Game Works and other amusement related activities.

[10] HOTEL

Identifies Hotel Establishments.

[11] EXPORT

Includes Transshipment and Exportation of Goods.
