SUBJECT: Federal Consistency Certification for the USEPA General Permit for Bulk Fuel Storage Facilities in Guam (GUG000001) *GCMP FC No. 2018-0018*

Hafa Adai! The Bureau of Statistics and Plans is reviewing the enclosed Federal Consistency Certification for the United States Environmental Protection Agency (USEPA). The Regional Administrator, EPA, Region 9, proposed issuing a National Pollutant Discharge Elimination System (NPDES) general permit for discharges from bulk fuel storage facilities in the territory of Guam. This new general permit is intended to replace the individual NPDES permits for five bulk fuel storage facilities and provide coverage for new eligible bulk fuel storage facilities.

This permit will additionally authorize discharges from the following five bulk fuel storage facilities operating in Guam: Mobil Oil Guam Inc./Cabras Terminal, Tristar Guam F-1 Pier Terminal, South Pacific Petroleum Corporation/Cabras Island Terminal, Tristar Guam Agat Terminal, and Guam Power Authority Piti Terminal.

This permit establishes effluent limitations, prohibitions, reporting requirements, and other conditions on discharges from the above named bulk fuel storage facilities located in

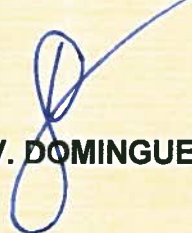
Southern Guam.

We respectfully request for your agency's review of the proposed project pursuant to Executive Order 78-37, Guam Land Use Policies relative to the 16 Development and Resource Policies.
