SUBJECT: GENERAL NEGATIVE DETERMINATION: Fiscal Year (FY) 2021 Camp Blaz Main Cantonment Vertical Construction Projects: P-311, P-312, P-317, P-802, P-803, P-804, J-015, J-018, J-023, J-032, J-034, J-036, J-037, J-038, J-039, J-301, and J-318.

Dear Mr. Taitano,

The Department of the Navy requests the Guam Bureau of Statistics and Plan's (BSP) review of our phased determination for the subject vertical construction projects at the future Camp Blaz Main Cantonment, Naval Base Guam Telecommunication Site (NBGTS), as part of the 2015 Record of Decision (ROD) for the Marine Corps Relocation on Guam. Guam BSP's conditional concurrence with the Navy's Programmatic Consistency Determination (PCD) was formalized on 27 August 2014 with continued support for the phased determination process. Also formalized is streamlining provided under with Title 15 Code of Federal Regulations (CFR) Part 930.35(d), allowing submission of General Negative Determinations for eligible follow-on vertical construction projects.

The Main Cantonment utilities and site preparation work under J-001B is near completion and has prepared the site for vertical construction. P-311, P-312, P-317, P-802, P-803, P-804, J-015, J-018, J-023, J-032, J-034, J-036, J-037, J-038, J-039, J-301, and J-318, are vertical construction projects contained within the J-001B Main Cantonment project foot print. All projects are pending award in FY2021. The Navy thereby submits this General Negative Determination for further development at this site.

The Navy has assessed any reasonably foreseeable direct and indirect effects on Guam's defined coastal zone, and reviewed relevant management programs (enforceable policies) of the Guam Coastal Management Program (GCMP) in accordance with the Coastal Zone Management Act (CZMA). The follow-on vertical construction projects at the Main Cantonment would not have discernible spillover (indirect and cumulative) impacts to the Guam coastal zone beyond or in addition to those already assessed under the J-001B project (Reference: BSP Federal Consistency No. 2017-0018 and resolved per Naval Facilities Engineering Command Marianas Ser EV/750). There would be no direct impact to the coastal zone, as reasonably foreseeable effects are confined to land under federal jurisdiction.

Included in the Navy's General Negative Determination of coastal effects is the finding that all subject developments under the Marine Corps Relocation would comply with and would be conducted (or supported) in a manner consistent with the policies of the GCMP to the maximum extent practicable. The Navy will incorporate programmatic requirements as set forth by the BSP in prior conditional concurrence granted for the Marine Corps Relocation program, and all follow-on vertical projects shall also adopt any applicable conditions BSP has placed on the J-001B project.

Please see enclosures for project descriptions, vicinity maps, coastal effects determinations and other supporting information. The status list of planned and future vertical facilities at the Main Cantonment shall be updated with your agency on a semiannual basis or as new information becomes available.
