

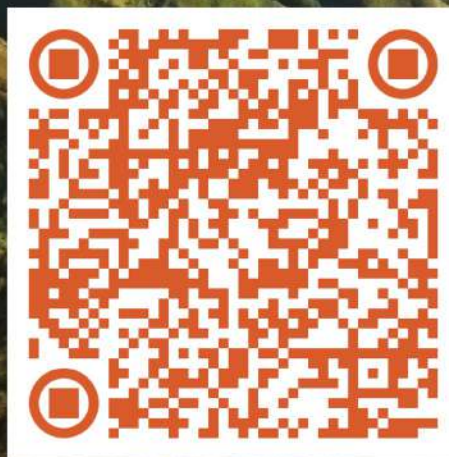

Procedures and Protocols for the Discovery or Presence of Historic Artifacts

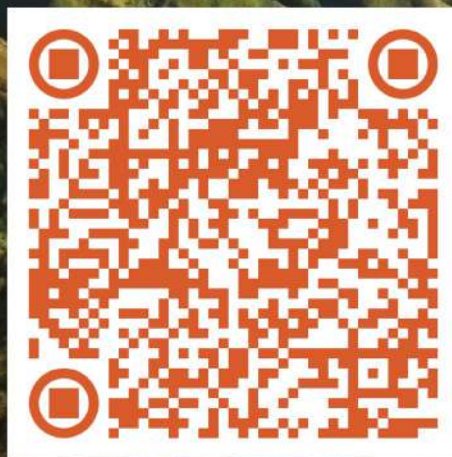
