### Goals of the Forest System Plan


- Goal 1. Manage watersheds to protect and improve water quality of surface water, groundwater, and nearshore marine habitats.
- Goal 2. Maintain and enhance biological integrity of native ecosystems.
- Goal 3. Support public access to the Forest System.
- Goal 4. Strengthen the economy by sustainable use of forest products, and protection of key forest ecosystem services, such as flood abatement, erosion control, carbon fixation, and ecotourism.

### Guam Forest System Plan (FSP) Augments Guam DOAG's mandated responsibilities and authorities...

- "of developing and protecting the agriculture, natural resources, and aquatic and wildlife resources of Guam"
- DOAG is mandated with developing the Guam FSP
  - Potential uses in the Forest System for public benefits
  - Maintenance and enhancement of the overall quality of the environment
  - Shall contain: land inventory, lot number, size and location, a comprehensive and concise definition of the public interest in the system; proposals for maintenance and enhancement of the overall quality of the system environment; stipulations on public access for recreational and educational use; etc...

## Proposals for Collaboration and Future Additions to the Forest System

- Future additions per 5 GCA §63504(f)
- Memorandum of Agreements with Government Agencies, including the Chamorro Land Trust Commission (CLTC), the Guam Ancestral Lands Commission (ALC), the Guam Territorial Park System reserved properties classified as Natural Preserves and Conservation Reserves, Guam Environmental Protection Agency and the Department of Land Management for properties under the jurisdiction of the Guam Territorial Seashore Protection Act of 1974.
- Reservation of land
- Securing of conservation easements

# Forests and Open Space Management Practices

- Improving Forest Health and Native Plant and Animal Species
- Erosion and Sedimentation Control
- Ecotourism and recreational activities



# Wildfire prevention and suppression

- Installation and maintenance of firebreaks and fuels reduction efforts within management areas and areas of high risk.
- Continue to conduct fire suppression activities, wildland fire investigations, wildland fire trainings, and build upon coordination efforts with fire partners to include but not limited to the Guam Fire Department, Joint Region Marianas Fire and Emergency Services: inclusive of Naval Base Guam, Marine Corps Base Camp Blaz and Andersen Air Force Base, village mayors and stakeholders.
- Develop Community Wildfire Protection Plans ("CWPPs") for management areas and neighboring communities to identify and prioritize areas for hazardous fuel reduction treatments and recommendations to break the fire cycle.



### Biosecurity and invasive species control

- Identification, monitoring, and or removal of invasive plant and animal populations.
- Targeted control projects for specific species.
- Landscape level control for specific species, where feasible and appropriate.
- Ungulate control or eradication, including fenced enclosures where appropriate.
- Collaboration with neighboring landowners for landscape scale control and joint 4 management actions.
- Implementation of biosecurity programs to prevent the introduction of new species into 6 management areas or areas with especially vulnerable species populations.



### Plan Support And Approval

- Draft plan submitted to the Office of the Governor on May 11, 2022
- Written approval of the Governor received on August 22, 2022
- Public Hearing on June 10, 2024
- Guam Forest System Plan Summit held on June 20, 2024
- 2<sup>nd</sup> Notice of Public Hearings from the Guam Legislature, October 28, 2024
- Bill 363-37 (COR) into law as Public Law No. 37-143 on December 28, 2024
