FORWARD

The Bureau of Planning has been designated under Public Law 12-200 to develop the land-use element of the Guam Comprehensive Development Plan. A major part of a land-use element involves the analysis of existing codes relevant to legal authorities and enabling legislation dealing with land use. This report is an up-to-date presentation of those sections of the code which have been changed since its publication in 1970.

Comprehensive Planning is composed both of substantive content dealing with the physical realities of growth as it affects Guam, and procedural content examining the means by which a plan is to be implemented. This report is of a procedural nature objectively defining the process of land and water use control as it stands now with an aim of developing recommendations for streamlining the process in the future.

INTRODUCTION

The Coastal Zone Management (CZM) Program is an integral part of the land-use planning process on Guam. The program is supported by a grant to the Bureau of Planning from the Office of Coastal Zone Management (OCZM), US Department of Commerce.

The geography of Guam is such that almost any land use decision has an impact on our water resources. In this report, as in other CZM documents, land and water use are treated as parts of a single topic.

The work program of the CZM grant includes a mandatory review of land-use legislation with particular emphasis on the land use permitting process. The CZM staff has developed several products with respect to land-use legislation and permitting.

This report was designed to satisfy the need for an up-to-date presentation of the Government Code. This report tells the reader:

- . Which Sections of the Government Code relevant to land-use planning have been added, deleted, or amended since the publication of the Code in 1970.
- The public law which enacted the change, thus providing access to a current statement of that particular section.

Another CZM land-use legislation report is a (preliminary) table entitled Summary Chart of Major Government of Guam Laws Related to Land Use which appears on pages LND 5-15 of the Bureau of Planning's Guam Inventory of Planning Information. This chart cites:

- . The kind of land covered by a particular law.
- . The agency with principal responsibility for that law.
- . The agency's enabling legislation.
- . The program or plan relevant to this kind of land or the law.
- . The agency responsible for implementation.
- Explanatory notes and comments.

CZM staff has been preparing additional land-use legislation reports and guides as well. Briefly, these include:

. Flow charts showing the major land-use permitting processes (zoning, subdivisions, building permits, Corps of Engineer permits, etc.).

- . A listing of all executive orders relevant to land use.
- . A listing of enabling legislation for boards and commissions with powers relevant to land-use planning.

Readers are encouraged to forward their comments, corrections, and suggestions to this office. This will be of great help to us when preparing future land-use legislation reports. We are considering updating this report at the end of the current legislative session and would be able to incorporate any changes at that time. The format of this report was chosen to allow more detailed and extensive remarks and comments on the law: Suggestions from readers as to how this report might best be developed will be welcome. Timely (early) responses would be appreciated.

SCOPE OF THIS REPORT

Coverage

This report covers only those Titles of the Government Code relevant to land and water use. The titles are listed in the Table of Contents.

Every Public Law enacted in the 10th, 11th, and 12th Guam Legislatures has been covered as well as all Public Laws of the 13th Guam Legislature through Public Law 13-168. Only those changes to the selected Titles are recorded. All other changes were ignored.

For the 10th, 11th, and the first session of the 12th Legislatures, the information was taken from the 1973 Cumulative Supplement to the Government Code. For the second session of the 12th Legislature (PL 12-71 on) and Public Laws 13-1 through 13-168, the researcher read the laws on file in the Attorney General's office.

Some changes to the Government Code are not recorded in this report. The supplements to the Code do not report changes to Sections if the entire Chapter has been repealed. Thus, if a Chapter was repealed before 1974 (before the second session of the 12th Legislature), the changes to individual Sections prior to the repeal are not recorded here.

Structure

Basically, this report is organized by Chapters of the Government Code. The entries look like this:

CHAPTER number name
Sections first through last **

(for each Section which has been changed:)
Section number type of change Public Law number; effective date

** If there has been no changes to any Section of the Chapter, a note appears: "(no changes)"

When there are Articles within a Chapter, the changes are reported by Article.

When necessary for clarity, this report departs from the format. Explanatory notes have been added selectively.

Numbering Changes

When the number of a Title, Chapter, or Section has been changed by the Editor of the Code, the new number is used and the number originally assigned by the Legislature appears in parenthesis.

Effective Dates

When the effective date of a change is noted, it was copied from the 1974 Cummulative Supplement to the Government Code. Effective dates, in general, are shown for all public laws except those of the 13th Guam Legislature.

Conditional Effectiveness

Wherever possible, the researcher has noted where specific conditions still must be met before a law takes effect. Where such conditions were specified in a public law and have been met, no note appears.

RESEARCHER'S OBSERVATION

Many of the public laws included the following phrase or its equivalent:

Any provision of law which in any way contradicts the provisions of this Act is hereby repealed to the extent of such contradiction.

The continued use of such a phrase means that no Section of the Government Code can be relied upon to be in force as some public law, unknown in all its details, may have repealed the Section. Worse, it is often a matter of pure conjecture whether or not a contradiction does indeed exist between Code Sections.

While such a technique may be required in an emergency or crisis, the continued and frequent replacement of thorough legal research with a catchall phrase hampers the proper and effective functioning of government.

A comprehensive review of the law which would include specifying these contradictory Sections is overdue.

1974 GOVERNMENT CODE SUPPLEMENT - ERRATA

Several errors were discovered in the 1974 Supplement during the course of this project. It is recommended that those persons with copies of the 1974 Supplement make the appropriate notations.

There is an unfortunate confusion between Public Laws 12-108 and 12-226 in the Supplement. Specifically, the repeals of Chapters VI, VIII, and XI of Title XIV (Land Management) and the addition of the new Chapter VI of Title XIV are credited to Public Law 12-108 instead of Public Law 12-226 (which enacted these changes).

The notations which must be changed are: those following Sections 13501, 13503, and 13516; those under Chapters VII, VIII, and XI. In addition, the notation following Section 13516 cites Section 13505(b); whereas the correct citation would be Section 13503(b).

This error has been compounded with respect to the amendment of Section 13956.1 of Chapter XI of Title XIV (Land Management) by Public Law 12-193. The editor of the Code states that Public Law 12-193 "purported to amend Section 13956.1" whereas, if Public Law 12-108 had repealed Chapter XI, this would be impossible. But Public Law 12-108 did not include any reference to Chapter XI. Thus, Section 13956.1 was in force at the time it was amended by Public Law 12-193. The entire chapter was then repealed by Public Law 12-226. (See the editor's note at Section 13956.1.)

Articles 2, 3, and 4 of Chapter IV of Title XII (Department of Agriculture) were repealed in their entirety by Public Law 12-209. No notation to this effect is in the Supplement (see page 271 of the changes to Volume I of the Code).

Section 17352 appears on page 81 of the changes to Volume II. The section is thus listed as part of Chapter XIII of Title XVIII. It should appear on the preceding page as part of Chapter VIII.

Section 19312.4 of Chapter IV of Title XX was added by Public Law 12-225. This section does not appear in the Supplement (see page 83 of the changes to Volume II of the Code).

Section $310\underline{47}(c)$ is incorrectly listed as Section $310\underline{37}(c)$ (see page 9 of the changes to Volume III of the Code).

TITLE LXI GUAM ENVIRONMENTAL PROTECTION AGENCY

Public Law 12-191 formed Title LXI by renumbering numerous sections of the Government Code and by assigning responsibility for the enforcement of these laws to GEPA. The reorganization was so extensive and the renumbering so involved that the format for recording changes to the Government Code used in this report is inadequate.

For more detailed information than is presented here, the reader is referred to:

- GEPA, which maintains copies of Title LXI as amended to date.
- The 1974 Cummulative Supplement to the Government Code, which includes all changes effected by PL 12-191 and, therefore, the current statement of Title LXI as of the close of the 12th Legislature.
