Hafa Adai and Greetings:

On behalf of the people of Guam, I welcome participants, delegates, and observers to the Conference on Sea Law, to be held on Guam on April 6th through 9th, 1977. I commend the Pacific Asian Studies Association for planning the Conference. The Conference deals with a problem global in nature - the question of man's use of the ocean resources.

Hugo Grotius, a famous writer of international law, stated "that the sea by its very nature cannot be the property of a state." This principle left nations the freedom to use the high seas, in navigation, in fishing, flying over the high seas, and to establish international communication. Traditionally, the open seas has been used for commerce. Today, the importance of the seas becomes more crucial, as scientists discovered abundant food and mineral resources in the deep seas.

I recognize that the United Nations has already sponsored three international conferences on the law of the sea. The Conference that the Pacific Asian Studies Association now proposes is the first to be held in the Asian-Pacific Basin. The lives of millions of island people would be greatly affected by the future regulations and solutions arrived at by various countries on the uses of the sea.

Through this Conference, the peoples and nations of the Pacific community will find a forum to express their own views on a very important global problem. I urge you to come and attend this exciting conference. Your presence will greatly enhance the success of the Conference.

The basis for the conference will be an analysis of the present proposed Sea Law agreement of the special United Nations sponsored Sea Law Conference. Through the support of the Governor of Guam and the business and legal community of Guam the association will arrange to bring to Guam four senior authorities in the areas of law, economics, and marine science to explore the impact of the proposed Sea Law agreements. In addition, the Guam Department of Commerce and the University of Guam personnel will assist in the preparation and presentation of the Conference Seminars. The Pacific Asian Studies Association cordially invites the attendance of all interested parties at the Conference to be held on Guam from April 6 - 9, 1977. Both active participants in the Seminars and observers are invited to attend this conference. 
