# GUAM INANGOKKON PRESERVATION INADAHI GUAHAN TRUST

The Guam Preservation Trust (GPT) was created as a nonprofit public corporation in 1990 by Public Law 20-151, and recodified in 2004 by Public Law 27-89. Its mandated purposes are:

To seek outside grants and donations

To acquire title to threatened Guam-properties for the preservation of their historical value, whether in fee simple, by leasehold, or by easement, and whether through donation, transfer, dedication or purchase;

To award grants for:

Historic property documentation and historic register nomination; Architectural and archeological history and documentation of historic structures and sites;

Protection of historic structures and sites through stabilization, rehabilitation, reconstruction, or restoration, including lighting when appropriate on such sites being utilized for non-profit and non commercial purposes, such as private homes, schools, churches, public buildings and facilities;

Éthnography and oral history of Guam;

Archival and archaeological research and investigations for locating, recording and protecting sites of historic or prehistoric interest or value;

To support other activities directly related to increasing the public appreciation of, and benefit from historic places including public interpretation and presentation.

The plan's framework is goal-oriented and therefore provides strategies that if coordinated well, will bring together Guam's citizens and the preservation community to identify where our diverse goals complement historic preservation and how we can all work together to ultimately preserve Guam's heritage.

We look to the Guam State Historic Preservation Office at the Guam Department of Parks and Recreation as the lead agency for Guam's historic preservation and therefore recognize that this plan is a component of the Guam State Historic Preservation Master Plan that we hoped to integrate.

In setting the stage for the development of this plan, we have used the positive change approach as we engaged with the preservation community and the public. From the establishment of the advisory group, to the meetings with stakeholders, our focus on the strengths and skills of the community has made the planning process clear and productive.

## Methodology

The methodology applied to the process of developing the plan is the positive change method called the Appreciative Inquiry (often known as AI). The Appreciative Inquiry focuses on the strengths of the community to foster strategies that identifies the best of "what is" to pursue the possibilities of "what could be".

The Appreciative Inquiry was developed by David Cooperrider and Surech Srivastva in the 1980s. The approach is based on the premise that "organizations change in the direction which they inquire." So if we had taken the problems/issues-based approach, which inquires into problems, we will keep finding problems. But if we continue to appreciate what is positive in what our community can offer, we will discover more and more what is best. We can then use these discoveries to build a new future where the best becomes more common.

The Appreciative Inquiry approach is often worked out in practice by using the '4-D' model:

**Discover**—people talk to one another, often via structured interviews, to discover the times when the organization is at its best. These stories are told as richly as possible.

**Dream**—the dream phase is often run as a large group conference where people are encouraged to envision the organization as if the peak moments discovered in the 'discover' phase were the norm rather than exceptional.

**Design**—a small team is empowered to go away and design ways of creating the organization dreamed in the conference(s).

Deliver—the final phase is to implement the changes.



## **Findings**

The results of the appreciative inquiry process conducted at the 2006 Historic Preservation Symposium produced two major findings: 1.) The first most obvious finding was the consensus that the top three goals for the Guam Preservation Trust to address were: a.) Ethnography & Oral History; b.) Repair, Rehabilitation, Restoration or Renovation of Historic Buildings and Structures; and c.) Archaeological Research. 2.) The second finding was through the compilation and analysis of AI responses. The analysis indicated three clusters of recommended strategies: a.) Education; b.) Historic Resource Development; and c.) Community Awareness.



# **Historic Property Documentation and Register Nomination**

The Guam Preservation Trust will provide opportunities for the documentation of the historic significance of places, objects, structures, buildings, and sites, and in the formal process for registration and nomination for listing on the Guam and/or National Register of Historic Places.

## **Archival Research**

The Guam Preservation Trust, in collaboration with archival organizations, will develop and provide archival research that focuses on specific historic places or broad patterns of events significant in Guam's history for public education and appreciation.

## **Architectural History**

The Guam Preservation Trust, in collaboration with architectural and engineering organizations, will develop architectural research and documentation of historic structures for use in rehabilitation, renovation, restoration, or re-construction.



# Ethnography and Oral History

### Standard of Success

The Guam Preservation Trust, in collaboration with organizations involved in ethnography and oral history, will dedicate resources, to research and document: 1.) historic places; 2.) traditional cultural values and practices; significant to Guam.

## **Proposed Outcomes**

1. Comprehensive Ethnography & Oral History Program for Schools

# Archaeological Research

## Standard of Success

The Guam Preservation Trust will work with archaeological organizations to provide for archaeological research to better understand Guam's history.

## **Proposed Outcomes**

1. Archaeology & Museum Program at the University of Guam

Coordinate Archaeology & Museum studies programs with the University of Guam through partnerships with the community. This will include scholarships and program support.

Proposed Lead Organization: University of Guam (UOG)

**Proposed Collaborators:** Guam Preservation Trust, State Historic Preservation Office, Department of Chamorro Affairs (DCA), and Private Archaeological Firms.

Estimated Cost: \$20,500.00 Proposed Funding Source(s): UOG, GPT, DCA,

Milestones: Start Date: November 2006. Expected Completion Date: June 2007

2. Community/Educational Awareness Program about Archaeology on Guam and the Mariana Islands.

Coordinate an awareness campaign program about the importance of archaeology and its relation to Guam's history. This will include field studies and other programs designed for school-aged youth, senior citizens, and a teacher institute for Chamorro teachers and history of Guam teachers.

Proposed Lead Organization: SHPO

Proposed Collaborators: GPSS, DODEA, Private Schools, GPT, UOG, Archaeological Firms, DCA, GHC, CAHA, GVB.

Estimated Cost: \$150,000.00 Proposed Funding Source(s): DCA (Legislative Funding), GPT, ANA Grant, and UOG. Milestones: Start Date: June 2008 Expected Completion Date: 2010.


# Historic Property & Documentation and Register Nomination

#### Standard of Success

The Guam Preservation Trust will provide opportunities for the documentation of the historic significance of places, objects, structures, buildings, and sites, and in the formal process for registration and nomination for listing on the Guam and/or National Register of Historic Places.

Manenggon Memorial Site: Hånom Nina'la - Water of Life
Kennosuke Iriyama, Consul General of Japan, hands a bucket of water from the Manenggon and
Yilig Rivers as a symbol of peace to Rita Torres Franquez, Manenggon Concentration Survivor
and Manenggon Foundation Board Member at the dedication of the Manenggon Memorial
Fountain on July 10, 2004.

Please note that the former Consul General was not intended to participate in this ceremony, but at the last minute, Rita invited him from his seat and he accepted. The intention of the ceremony was to take the waters of the two Rivers that provided life for those who were encamped at Manenggon and pour it into the fountain just seconds before the pump was turned on. Therefore, it's not a forgiveness gesture, but a symbol of the survivor's extension of life.
