My first taste of politics came from setting up signs and what must have been a thousand tiki torches on Ricky's Beach. I ended up smelling like diesel for two weeks, but it was all part of a valuable education.

The Bordallo-Taitano campaign was called "New Day," and it was a particularly fitting slogan for me. My "New Day" began as I took my first lessons in politics from one of Guam's greatest leaders. I learned so much from Ricky. Ricky was a man who led by example, and no man showed as much determination, compassion, and generosity as he did. He was my mentor, but more than that, he was my close personal friend.

Ricky's many accomplishments, his daring leadership style, and most especially his dedication and love for the people of Guam continue to inspire me and many of our island leaders today. His strong leadership was especially vital during those early days of Guam's fledgling government. His lasting contributions to our community, both politically and personally, cannot be measured. He was a true advocate of our people.

One of Ricky's greatest legacies is our island's quest for Commonwealth. Ricky was a vigorous champion of Chamorro rights and culture, and proved himself one of our people's true heroes. And he was no less a hero at home, being a proud father and devoted husband, as well as a warm friend to all who knew him.

The dedication of the Adelup Complex as the Ricardo J. Bordallo Governor's Complex is a fitting tribute to this great man. A public servant for over 40 years — a Senator for 7 terms and Governor for two — Ricky's legacy is as imposing as the structure which now bears his name. His place in Guam's history is secure, and he will forever be in the hearts and minds of our people.

A TRIBUTE TO GOVERNOR RICARDO JEROME BORDALLO EDWARD DIEGO REYES

I am pleased to write this tribute on behalf of Governor Ricardo J. Bordallo on the occasion of the dedication naming the Adelup Complex in his honor. I am similarly privileged to have served Guam along-side this great leader as partner during his second term as Governor of Guam. Ricky so loved Guam that he was quite willing to give up his life for her people.

Many on Guam, and the world for that matter, have occupied positions of leadership in high places and do a fair job while others still simply masquerade as leaders. Indeed, the emergence of real leadership is rare and far between. Ricardo J. Bordallo is one such rare, real leader who came forth to lead this Island with distinction as twice Governor, seven terms as Senator in the Guam Legislature, and as an entrepreneur in the business community.

Inspite of the heavy demands of his office, Ricky single-handedly built the Democratic Party of Guam over the years to the height of its strength in 1987 when he left the political scene. Most assuredly not by choice. The vast majority of democrats on island consider the Democratic party of Guam synonymous with the name Ricky Bordallo.

Ricky's accomplishments were unsurpassed by anyone else who has ever ascended to the Position as Governor of Guam. the Island is studded with the numerous things, important things, he has done to elevate the quality of life of people on this Island.

As early as 1974 at the start of his first administration, Ricky foresaw the coming of an economic boom in the tourism industry which in fact came in the last half of the 1980's. Keeping this in mind he took immediate action to prepare the Island for this eventuality. He embarked on a massive program to develop Tumon Bay with the needed infrastructure which would allow the construction of over 5,000 room hotels for the tourists. At the same time he proceeded to infuse the Island with other infrastructure projects which would not only compliment tourism but also benefit the Island as a whole. He inserted over 30 miles of upgraded water and sewer lines, several sewer treatment plants, over half a dozen large water Reservoirs, and dug over 20 water wells. He also expanded over 20 miles of the major highways and replaced 8 bridges. He planned and funded the construction of the New Airport.

Yet ever mindful of the need of the local people, he took action to acquire the structure which now houses the

Guam Memorial Hospital; he built numerous community centers throughout the Island and constructed at least 200 Low Cost Housing units for the poor and the elderly. These are but a few examples of what Ricky has done for the Island. Others are too numerous to cover her. But perhaps the Crowning Jewel of his efforts is the construction and completion of the Adelup facility and Government House. Ricky often referred to Government House as "the house of the People," where all can come to take pride and enjoy the symbolic beauty of Guam.

Ricky was not only a builder but as much a visionary and an idealist who kept a constant focus on what is good for the people. He believed in the philosophy that if you take care of the people in the villages, the working people, that most everything else will fall into place. The economy will grow, jobs will increase, and overall the people's quality of life will improve. He was of course very correct. Much of the things we enjoy today is because he came and made a tremendous imprint on this beautiful Island.

On Federal-Territorial relation, Ricky provided the strategic guidance for the crafting of the proposed Commonwealth Act of Guam which was ratified in a referendum by the people and is now pending consideration by the U.S. Government. He fervently believed that Guam could achieve a greater degree of justice if only the U.S. will grant a measure of self-determination and freedom form the shackles of federal restrictions.

Frustrated by U.S. inaction he once told Washington in no uncertain terms to "Give us Justice or Set us Free". That shocked the Feds especially in light of the "Cold War" and the vital strategic significance of Guam in projecting U.S. military power in this part of the world. I am convinced that bold statement prompted a massive effort by the federal government in collaboration with local political operatives brought about Ricky's political down fall. But that is Ricky, he's unafraid to express his convictions, no matter what!

Ricky came and went; but his name will long be remembered and his legacy will remain forever. So it is entirely fitting and proper that we honor today this great leader, this true patriot son of Guam by naming the Adelup facility as the Ricardo Jerome Bordallo Governor's Complex.

If there is a lesson to be gained from the endeavors of Ricardo J. Bordallo, it is that a political



leader and his ideas need not be relegated to the library or to an ivory tower detached from the currents of his time. With zeal and consuming passion, political leaders can get their ideas into practice.

Ricky's fixation with issues like empowerment of people and people-oriented governance drew him into discussions on the anomalies of Guam's political status. He saw Guam's status central to the "whole" which needed to be reformed if the economy, the administrative structures of government, and the societal configuration were to be reformed.

Ricky's interest in the political system was intense, because it was the arena in which equality for the people of Guam, and protection of their interests and welfare could be best addressed. He said, "Guam, to the United States is viewed as a show-window of American democracy in the Pacific; but this window is only half-open to the people of the Territory because the expression of their popular will for a more legitimate political status has yet to be responded to."

Ricky's movement for a new political status for Guam and for more citizen participation in government was ahead of its time, but it isn't something that can be ignored for long. Less than seven years later, his political status goals have evolved into popular movements among all segments of the island.

During his tenure, he sought to strengthen the administrative system to make it work not just better, but smarter, identifying its weaknesses and idiosyncracies. Ricky's preoccupation with public accountability, complimented by his people-oriented philosophy towards improving and reforming government may not have influenced unwilling minds but it found its way into helping the people of Guam.

I often describe this trend to my UOG students this way: the "public" in Public Administration, was originally assumed to mean the government or public organizations. It was redefined by Ricardo J. Bordallo to refer to "the people," which the administrative system purports to serve. In this Bordallo-led incarnation, the practice of Public Administration focuses less on the government institution and more on who it serves.

It is incorrect to attribute to Governor Bordallo alone what Guam has become today, but it is not wrong to say that he did much to make Guam what it is. His legacies and contributions have had a profound effect on the development of our island. But, if he were with us now, he would probably refuse to acknowledge any credit for this progress. That's just the way he was.

Ricardo J. Bordallo provided



leadership in his own inspiring, sometimes obsessive ways, and he triumphed over adversity. It's what champions and winners always do. What more could be said of the man, but that he served well his God, island, and people.

ROBERT G.P. CRUZ

Governor Bordallo gave young persons the opportunity to serve as leaders. The late Gene Ramsey and myself are two examples. At twenty-five, I was selected by the Parks and Recreation Commission and approved by the Governor to be the first Director of the Department of Parks and Recreation. I concurrently served as State Historic Preservation Officer, responsible for identifying and protecting our historic buildings and archaeological sites. As Director, I had the privilege of shaping the development of our park system, and

youth and community recreation programs and facilities.

I will never forget or regret experiencing Governor Bordallo's tireless leadership or vision. He recorded thousands of thoughts on a micro tape recorder, and had his staff transcribe and follow up on what involved your agency.

He supported innovation and hard work, but expected you to be accountable for you agency's performance. You might be called to his residence for a private sunrise breakfast to hear his displeasure over some short coming, or called to attend his "subcabinet" meetings with all the village mayors to respond to their concerns. And no one could forget the marathon sessions during the annual village meetings where the entire cabinet attended evening meetings to face citizen's complaints — on their own turf.

At the end of his first term, his letters of recommendation helped me get accepted by nine law schools. When I returned, he asked me to accept a cabinet position during his second term. Although I chose to build my legal experience by working as a law clerk at the Superior Court and as an Assistant Attorney General specializing in administrative law and hearings, he still sought me out for brief periods of service as Acting Legal Counsel, Office of the Governor.

Governor Bordallo amazed me with his ability to analyze a person's argument, rationalize how it could be wrong, and then convince that person why the Governor's interpretation was the better


approach or position to take. He probably would have made a brilliant trial attorney.

Reflecting upon all of the responsible positions I have

held, I believe that it was that first cabinet position I held which gave me the confidence to aspire to other positions of leadership, and to try to make a difference in our community.











CATHY GAULT

When President Reagan's speech writer published her book, "What I Saw At the Revolution," I chuckled and thought back to 1983, when I joined Governor Bordallo's staff.

It was three days after the inauguration and the office was still in the throes of transition. The place was a confusing mess, and I wondered what I had gotten myself into. I had come from the private sector and GovGuam was mind-boggling, even from inside the top. As I sat at my temporary desk feeling utterly stupid, a cheerful face with a handlebar mustache appeared at the door. The mustache introduced himself as John Benavente, the incoming Veterans Affairs director. After some perfunctory chit-chat I told John how lost I felt. John told me not to worry, that I'd be a veteran in a month, and "when this is all over, you can write a book and call it 'My Four Years in the Trenches."

John probably didn't know how prophetic he'd been. Someday I do hope to write a book, but it won't just be about my years in the trenches as Governor Bordallo's press secretary. More than anything, I want to share the three succeeding years I spent helping him write his autobiography. Oh the stories I could tell - like the time he made kadon ox tail, left the pot on the stove, and forgot all about it ... until it started to stink up the house. Madeleine, a fastidious housekeeper, was off island but due home that evening, "She's gonna kill me," he said when I arrived for that day's interview session. So instead of book

work, we cleaned the kitchen and tried to get rid of the smell.

Then there was time he set the lawn mower blade too

low and shaved the lawn down to the roots. He insisted it wasn't a mistake — it was an experiment, to see if the grass would grow back more evenly. It did.

During the renovation of Adelup, the Gov pitched in and helped with the

grounds work whenever possible. We often had to go looking for him somewhere on

the grounds of Adelup. On one such search, I found him standing near the rock wall below the Hafa Ada Pavilion. (Chief of Staff John Whitt joked that if Ricky hadn't run out of rocks, the wall would go all the way around Guam). The Gov was gazing north toward Agana. He seemed lost in thought and I was hesitant about disturbing him. He sensed my presence and turned toward me. "This is why the Governor's Office should be here." When the pressures of work become overwhelming, he said, the Governor and his staff can simply step outside, take a deep breath of sea breeze, look around, and see what they are working for. At Adelup, he said, no Governor would be able to escape the reminders that he works for the people of Guam.

FRANCISCO "FRANK" S. N. TAIJERON, FIRST APPOINTED FIRE CHIEF OF THE GUAM FIRE DEPARTMENT

Governor Bordallo was not only a builder, but was commonly called a "dreamer." All one has to do is look around the island and see the projects that were built in the fulfillment of that dream -- the restoration of the culture of the people and island he dearly loved.

Ricky was a governor who did not fear public outcries on projects or issues that were considered controversial. Some examples are the repair and renovation of the Government House after Typhoon Pamela and the conversion of the Adelup Elementary School into the present Governor's Office Complex which is being dedicated in his honor. Most of all, Ricky was a man of great understanding and compassion, always making time to listen to people's problems.

In short, Governor Bordallo was a man of great stature -- a great statesman. But

most significantly of all, he was a grassroots man. A man who believed in making the people first!

HERMAN D. SABLAN

Governor Bordallo was known as a

builder. He was commonly referred to as a man of vision. The most obvious landmark improvements on



Guam are testimonies to his imagination and energy. Today, these landmarks serve as monuments to a Governor that brought Guam's image in consonance with our main industry of tourism.

As a key staff member in his Governor's office, and as Director of GEPA, and one of his closest advisors, I had the opportunity to observe at first hand his gifted thinking process and endless energy. He was a master politician. I viewed him as a mentor and a source of inspiration.

Governor Bordallo envisioned balanced and blended development. He was sensitive to the island ecology and culture, while pursuing economic growth. Quality of life, to him, meant equality in opportunity, and prosperity. He was a man of the people.

Ricky was a controversial governor. He created controversy only because he had the foresight and courage to pursue projects, or issues that demanded imagination, and conceptual comprehension, that paved the way for development, dignity, and prosperity for the people. He was simply ahead of all others.

It would take a book to describe his colorful character — the impact of his leadership, and the dramatic conclusion of his career.

But, if we were to take the briefest exposition into his life, I would describe him as "a man who can stand as tall as the tallest, and be as short as the shortest." He was a statesman. He was a farmer. He was a businessman. He was a grassroots man. He was a man of the people.



February 1985. Hearing of the House Committee on Energy and Natural Resources, Washington DC; Chairman Sidney Yates presiding. It was my first official trip to DC.

I had joined Governor Bordallo's staff only recently. There was a lot to do, but the Governor was presenting Guam's Capital project request in Washington in two weeks and I had to put it together. Having just come from BBMR, I pieced together some previous requests to produce the new one.

I was jet-lagged, and awestruck and didn't want to stick my head in the "mouth of the lion" trying to field questions from powerful Congressmen. At the hearing, I noticed Chairman Yates was relaxed and was munching popcorn. He was like anyone else, I thought. That

calmed me somewhat.

Guam's presentation came after American Samoa, After Gov. Bordallo delivered his testimony. Chairman Yates asked how water was delivered to the people if there was such a big problem with the water system. The Gov. turned and stabbed an emphatic finger toward me! He introduced me and said I would respond. I nervously gave an overview of the water situation and explained how the funding would rectify it. I described how the Navy was helping to transport water to critical areas by supplying us with "water buffaloes." All of a sudden, Chairman Yates interrupted and said, "With today's technology, you need water buffaloes to carry water!?" The audience burst into laughter.


On the verge of panic, I looked around for help. Lassumed Yates knew that water buffaloes was the common nickname for water tankers, but he thought I meant four-legged beasts of burden. With my heart racing I explained the situation. Crestfallen, I glanced at the Gov. Did I mess up? No reaction, his expression never changed. Chairman Yates acknowledged my answer, congratulated the Gov. on a convincing presentation, and assured us that he would recommend something be done.

After the hearing, I lagged behind the others in embarrassment. The Governor never said a word about my performance and I was afraid to ask. That evening he said he sensed that Yates was briefed by interior officials to be wary of requests for more funding. (Gov. Bordallo always described the yearly budget hearings as collection trips.) He wanted me to respond because he knew I would be

viewed as the "new kid" — too new to do a credible snow job. That was a defining moment for me — I encountered



the genius of the man. Gov. Bordallo believed in the youth of Guam. He was a risk taker. Best of all, he understood human nature. Thank you, Gov. Bordallo and Lt. Gov. Eddie Reyes, for believing in us, your young guys.

...I Remember Ricky

JAMES G. SABLAN

I'd known the late Governor since 1976 having been appointed for the first time as a board member to the Guam Visitor's Bureau. My first and foremost impression of him was his strong leadership. His unique style marked the pinnacle of government, a milestone in the making of history on our island, not because of his striving to solidify our island's economy, but because he represented a leap from the old style of governance to the new.

His door was open to everyone. His personality was that of a down-to-earth individual. He always kept an open mind and adjusted to any level of conversation. Although he was governor, he was everyone's friend and honored his belief that everyone should be treated equally.

"A Working Man" was how many people would describe him. As a cabinet member (Deputy Director of the Guam Economic Development Authority



in 1982), I remember him to be a workaholic - he would start off many mornings with a wake up call to his cabinet members to provide us with our daily agenda. I remember many of his goals and visions to encourage, develop and stimulate the island's economy.

His work touched many lives. I remember well the vegetables and the trees he pruned side by side with farmers, a page right out of the program he created, "the Green Revolution."

"Commonwealth" was his prime goal. Throughout the years I worked under him, primarily when I was appointed President of the Guam Housing Corporation, I was most impressed with his strong desire to assist those striving to achieve their lifelong dreams.

One cannot dispute his many

accomplishments. He was and always will be in many minds a strong leader. He deserves much more than an historical commemoration of his achievements and he will always be remembered much more than just a Governor. As we unite to dedicate Adelup, I salute the late Honorable Governor Ricardo J. Bordallo.

JOHN (EDDIE) **ONEDERA**

The Governor through his leadership and vision assisted the General Manager of



Guam Power directly and indirectly in accomplishing his mission. GPA was indeed in big trouble during the late seventies for many reasons.

The Governor assisted GPA in convincing the US Congress to allow GPA to burn high sulfur fuel oil instead of the much more expensive low sulfur fuel oil. This adverted what would have been a big rate increase.

May 1976 brought Typhoon Pamela. It took GPA 31 days to completely restore electric service to the island, however, the Governor never requested for any special restoration other than for the hospital, clinics and water wells. I am thankful that the Governor left the restoration of power in the hands of GPA.

During the late months of 1976, the Governor decided to assist GPA with its \$36 million dollar deficit caused by building two 66 Megawatt Power Plants, a double circuit 115,000 volt transmission line and two 115,000 volt substations. Two weeks in Washington DC with the Governor visiting the Secretaries of Interior, Treasury, FHA, OMB and Congressman Won-Pat finally got GPA a Federal Loan, thanks to the Governor.

JOHN T. PALOMO

My personal/working relationship with the late Governor Bordallo is one meaningful experience which has greatly enhanced both my career and individuality. I have learned a lot about human compassion, government, and good politics by working with the governor. I am honored to have been

given the opportunity to share his vision and ideals that in this society nothing is permanent except change, and that people helping people is

What really stands out in my mind is that he tried to make things happen in spite of hard times. The economy was down and our revenue base was small. IOE CRUZ

I was privileged to serve in the first and second terms of Governor Ricardo J. Bordallo's cabinet. He placed his trust in me for eight years, as I served as Deputy Director for the Department of Public Health and Social Services, and Deputy Director of the Department of Administration in the first term. In the second term, I served as Chief Officer for the Public Utility Agency of Guam.

The eight years under Gov. Bordallo inspired the work ethic I have embraced. He also strengthened my deep belief about being more compassionate to my fellow persons and about being a more

active manager. I had to be proactive. He expected that of his cabinet members. He called often - and at any time of the day, 24



hours a day, seven days a week, in order to discuss ideas and issues. He devoted 24 hours a day for the people of Guam. He was committed to carrying the island and her people forward.

Governor Bordallo was a man of many facets. He was a man of compassion, a man of vision and a man of the future. Gov. He was ahead of his time. He envisioned a highway in central Guam that would run north to south. The utility rate at the time didn't capture the full operating cost of water and sewer services. After reviewing the study, we recommended to stop the subsidy, and this was presented to the Governor. The proposal meant a hike in the water and sewer services. After Gov. Bordallo accepted the proposal, it was presented to and accepted by the Public Utilities Commission. The rate was implemented, but the Legislature canceled it, and took over the ratemaking oversight for PUAG. The Legislature rolled back the rate.

You be the judge as to what would have happened if the Legislature had not done what it did in terms of the rate hike vis-a-vis recent chain of events on the matter as it affects the PUAG – now Guam Waterworks Authority.




Governor Bordallo always recognized the virtues and talents — hard work, faith, resourcefulness, intelligence — of the grassroots. Indeed, he amplified and

RICARDO JEROME

Born in Agana on December 11,1927, Ricardo Jerome Bordallo was the third of the sixteen children born to Josefina Pangelinan Torres, a gifted musician, and Baltazar Jeronimo Bordallo, an enterprising businessman and pioneering island statesman. From his parents, Ricky Bordallo learned a love and appreciation of music, a keen instinct for business, and a profound sense of duty to his community. Until his death on January 31, 1990, Ricky devoted his life to serving the people of Guam. His deep love for the people and for the island was reflected in all his efforts on their behalf.

Ricky Bordallo attended the Guam Institute until 1940. He then went on to George Washington High School, but his schooling was interrupted by the invasion and occupation of Guam in 1941. Guam's three years of enemy rule so deeply affected Ricky that he felt it his lifelong responsibility to protect and defend the people of Guam.

After the war, Ricky completed high school and graduated in 1947. With money he earned himself, he traveled to California



and enrolled at the University of San Francisco, a renowned Jesuit school. More than anything, Ricky wanted to be like his father, a successful businessman and statesman. At USF, he worked toward a business degree, but in his senior year he decided that he wanted to go into business, not just study it. He returned to Guam in 1950 and went to work for Bordallo Consolidated, owned and operated by his father, B.J., and his uncle, A.T. Bordallo, until he earned enough to venture out on his own.

In 1952, at age 24, Ricky Bordallo stirred controversy and made a bit of history by becoming the youngest candidate certified to run for a seat in the newly created Guam Legislature. He argued successfully that if he was elected he would turn 25, the legal age to hold public office, before inauguration day. He did not win the election and ran again in 1954.

In 1953, Ricky married
Madeleine Mary Zeien, the
daughter of George Washington
High School's first postwar
principal, Christian Zeien. The
Bordallos have one daughter,
Deborah, and a granddaughter,
Nicole. With Ricky's
encouragement, Madeleine ran
for office in 1980 and in 1987.
She was a member of the 16th,
19th, 20th, 21st, and 22nd
legislatures. She is now the
lieutenant governor of Guam,
having been elected in 1994.

Ricky's first election victory came in 1956, the same year in which he established Ricky's Auto Company and became Toyota's first American distributor. Over the next fourteen years, Ricky Bordallo would win re-election seven times and serve in the 4th through 10th Guam Legislatures, and Ricky's Auto Company would grow into Ricky's

Enterprises, a \$25 million conglomerate.

During his legislative career, Ricky championed the creation of the Guam delegate to Washington seat and elective governorship for Guam, among others. He also spearheaded the affiliation of the Popular Party of Guam with the National Democratic Party and served as the last chairman of the Popular Party and the first chairman of the new Democratic Party of Guam in 1960. He served as party chair again in 1971.

In 1970, after enactment of the 1968 Elective Governorship Act, Ricky Bordallo and Senator Richard F. Taitano won the Democratic nomination for governor and lieutenant governor for Guam's first gubernatorial election. In 1974, with Rudolph G. Sablan as his running mate, Ricky Bordallo was elected Governor of Guam. He ran for re-election with new running mate Dr. Pedro Sanchez in 1978 but was unsuccessful. With Edward D. Reyes as running mate, Ricky won the governorship again in 1982, becoming the first person in Guam's political history to win a

second term as governor. Ricky did not win re-election in 1986. Despite federal indictments which led to his conviction in 1987, Ricky did not abandon his service to the people of Guam. He actively campaigned for approval of the Draft Guam Commonwealth Act and against poker machines and casino gambling in Guam.

Gov. Bordallo maintained his innocence throughout his trial. In August 1989, the appeals court reversed all but two of the ten counts against him. He died five months later.

Ricky Bordallo's contributions to the people of Guam and to the Territory are immeasurable. Many of his capital projects -Government House, the



Emergency Operations Center, Sagan Dinaña, the second Guam International Airport building, the Northern Area Health Center, and the Adelup Executive Chambers - have become landmarks; others - like village playgrounds, parks, recreational facilities and highway improvements, such as the San Vitores Road expansion go unnoticed as they continue to serve the public. Whether large or small, all of Ricky's projects reflect his kindness and generosity, his warmth and admiration of beauty, and his love for the people of Guam.

Admired by many and criticized by some as a dreamer, a visionary, a consummate politician, and a master orator, Ricky was proudest of his role as simple farmer, a planter of fertile seeds. Perhaps his greatest gift to the Territory is development of young talent. Ricky believed in young people, in their ideas and enthusiasm, in their desire to serve the community, and in their ability to rise to the challenge to do so. Today there are many in leadership positions who proudly acknowledge Ricky Bordallo as their mentor and inspiration.

RICARDO J. BORDALLO GOVERNOR'S COMPLEX

Public Law 23-116 enacted into law designated the Adelup Complex to "hereafter be known as the 'Ricardo J. Bordallo Governor's Complex'." Introduced as Bill No. 29 by Senators Vicente C. Pangelinan, Ted S. Nelson, Sonny L. Orsini, and all other members of the 23rd Guam Legislature, this honor bestowed on Governor Bordallo was signed into law by Governor Carl T. C. Gutierrez on July 29, 1996.


Governor Bordallo is known for bringing his dreams to reality as demonstrated in the numerous islandwide projects which have been attributed to him. His love for his people was the driving force of his efforts in seeking the best for our island, from his work on the People's choice

for Commonwealth, to the abundance of beautification and capital improvement projects that reveal his legacy.

The renovation of the Adelup Complex is one such project which he personally directed and guided, single-handedly moving many of the boulders which are in place today. The rejuvenation of the old Adelup Elementary School has greater significance than most today can fathom. *Adiloc* means to bend and scan the ocean for fish, and our fishermen forefathers used the Adelup Point promontory for that purpose. Governor Bordallo saw Adelup as the point from which the people of Guam, with much pride and enthusiasm, would launch their quest for a final political status, as well as the cultural resurgence which will firmly establish their political and social identity in the world community.

A historical perspective on the many names of *Adiloc* is noted from the changing of hands since 1898 when Guam became a U.S. territory and the more recent titles are described. Having undergone three colonial powers the site has reflected influences of the Spanish, the Japanese and the American. During the Spanish era, the point was referred to as *Puntan Aniti* which was changed according to the chronicles as it passed through the hands of Congregational missionaries who then designated the area as "Missionary Point." The property was then sold and resold, at one point becoming the property of the Atkins Kroll Company, and later transformed into the residence of Naval Governor Shapely who christened it "Siesta Point."

With the outbreak of World War II, the Japanese built gunneries at the site, albeit being overtaken by the U.S. Third Marine Division during the liberation of Guam. This staking by



Commander Marianas led to the construction of Quonsets for the naval command, one such structure becoming the initial "Officers Club" built by the Seabees. With time and the establishment of bases throughout Guam, the Quonsets were turned into the Adelup Point Elementary School. In 1952 the concrete structure of the Adelup Point Elementary was designed by Richard Neutra and Robert Alexander to include 24 classrooms, an open-air cafeteria, a library, and principal's office taking into account the environmental factors to allow for a good educational setting. However, it was some of these same factors which led to the eroding of the school facility resulting in the closure of the school.

After some time had lapsed, and during his second term in office, Governor Ricardo J. Bordallo surveyed the school site and transformed the complex into the offices of the Governor. The renovations changed the dilapidated structure into the facility as we know it today, returning it to the People of Guam by housing the Executive Offices of the Governor and Lieutenant Governor, the Mayors Council, the Bureau of Budget and Management Research, and the Bureau of Planning. And while the complex has its own requirements for maintenance, its function is well established as our seat of government for the Island of Guam.

Perhaps the extensive protruding finger coral reef taunted the fishermen of the past to call the point *Adiloc* and served as the foundation of Ricky's vision of an impressive edifice to be shared with everyone, one which not only enhances the natural beauty of Guam but is the manifestation of the strength and fortitude of her people and their political ascendancy . . . presented as the halls of the highest office for our island — y Ufisinan Maga 'Lahe.
