

HOW GUAM LAWS ARE MADE

Bills

(1) A Senator may be requested by either a constituent, club, fraternity, business organization and so forth to introduce and back legislation to cope with a given situation. Oftentimes, he realizes the need for corrective and/or new legislation relating to various conditions that he himself is personally aware of. The Senator then consults with a member of the Research or Legal Branch who then makes a preliminary study as to its constitutionally and subsequent application should the proposed bill be enacted into law. If it merits further consideration, Counsel is then requested to draft a bill. This is referred to as a "member bill". Frequently, the Executive Branch requests the Legislature to introduce and entertain consideration on a bill that has been drafted by the Administration, this is known as an "Administration Bill", and is submitted to the Committee on Rules. After a bill has been drafted, it is presented to the Speaker of the House who then orders its first reading. Usually the bill is read by title only; however, it may, at times, be read in its entirety.

- (2) After having been read for the first time, a bill is then referred to the appropriate Standing Committee of the Legislature for consideration (for example, a bill relative to the construction of a school, would be referred to the Committee on Education). The Committee then conducts public hearings, studies and reports the bill back to the House with its recommendations, often with Committee amendments.
- (3) The bill is then placed in the second reading file of the Legislature for discussion. After debate the bill then, by motion, may be amended, placed in the inactive file or ordered engrossed and placed in the third reading file.
- (4) At the next legislative session the bill, being in the third reading file, is then ready to be voted upon by the Legislature as to whether or not it shall be passed. Ordinarily, bills require a majority vote of those members present, a quorum being present. However, if the bill is considered an urgency measure or has not been in process for 15 days, it requires 14 votes.
- (5) According to Section 19 of the Organic Act: Every bill passed by the Legislature shall, before it becomes a law, be entered upon the journal and presented to the Governor. If he approves it, he shall sign it, but if not, he shall except as hereinafter provided, return it, with his objections to the Legislature within ten days (Sundays excepted) after it shall have been presented to him. If he does not return it within such perios, it shall be a law in like manner as if he had signed it, unless the Legislature by adjournment prevents its return, in which case it shall be a law if signed by the Governor within thirty days after it shall have been presented to him; otherwise, it shall not be a law. (The Legislature only adjourns at the end of the second calendar year. Otherwise it is either in session or recess.) When a bill is returned by the Governor to the Legislature with his objections, (known as a "veto"), the Legislature shall enter his objections at large on its journal and, upon motion of a member of the Legislature, proceed to reconsider the bill. If after such reconsideration two-thirds of all the members of the Legislature pass the bill, it shall be a law. If any bill presented to the Governor contains serveral items of appropriation of money, he may object to one or more of such items, or any part or parts, portions, thereof, while approving he objects, and the items, or parts or portions thereof, so objected to shall not take effect. All laws enacted by the Legislature shall be reported by the Governor to the head of the department or agency designated by the President under Section 3 of this act, and by him to the Congress of the United States, which reserves the power and authority to annul the same.

Resolutions

(1) In addition to the introduction, consideration and action taken by the Legislature on bills, they also perform work of a similar nature on resolutions. While resolutions do not have the full force and effect of law, they do reflect the wishes of constituents, and they nevertheless play an important part in the functioning of the Legislature and also in the application that is sometimes given to bills that have already been passed. Resolutions require only a majority vote of those present, a quorum being present.
