





#### **PLANS**

Overall Economic Development Plan for Guam, 1976 Annual Progress Report; Bureau of Planning; September, 1976; 58 pages, 10 tables. The annual progress report is a discussion of additional areas of concern that need to be addressed to ensure that the initial OEDP remains current. Areas include changes in population; decreased employment, income, and government finance; and establishment of ultimate and intermediate economic development goals. The report reviews projects submitted for consideration in the initial OEDP five years ago. Development strategy and priorities for agriculture and tourism are outlined and the committee work plan lists developing potentials for consideration next year.

Overall Economic Development Plan; Guam Bureau of Planning; 1977; 141 pages. A discussion of development proposals for the Federal Economic Development Administration. Programs which are vital to Guam's economy include those for agriculture, tourism, Commercial Port, Guam International Air Terminal and water resources. A summary of EDA related, specific projects follows an exhaustive discussion of the various components of Guam's economy. Major chapters address population, labor force, and the economic potentials and constraints affecting the various sectors of the economy. Available: Bureau of Planning Library.

Growth Policy for Guam; Bureau of Planning; May, 1976; 77 pages, tables. The Growth Policy is a general policy statement for decision making in government. It is not a plan or program; rather, it is the framework under which plans and programs will be developed and to which they should adhere. The report presents an overview of the elements affected by population growth and their Growth Policy Statements. The Appendix contains position papers which provide background reports and more detailed recommendations of the five most important growth elements: Environment, Culture and Lifestyles, Agriculture, Tourism, and Light Industry. The agriculture growth policy is presented in another report and summarized here.

Five-Year Economic Plan; Bureau of Planning. The economic plan element of the Comprehensive Development Plan is currently being compiled and is expected to be completed in June, 1978. It will address economic growth potentials for the territory and outlines a five-year plan for economic growth. The emphasis will be on utilization of economic and statistical methodology to more accurately assess trends. Discussions will include the need and use of an economic plan and statement of general economic goals; an overview of the economy with a general description of the state of the economy, including trends in the recent past; economic resources and constraints, and sectorial strategies.

Economic Adjustment Program, Guam; the Office of Economic Adjustment, Office of the Assistant Secretary of Defense; July, 1977. This is a report of the President's Economic Adjustment Committee prepared under contract by Battelle Memorial Institute. The EAC aids communities experiencing serious economic difficulties caused by reduced Defense spending. The study includes an analysis of Guam's economic base and specific development problems; recommendations for an economic adjustment strategy to generate private sector jobs; and suggestions for a set of specific actions which will help implement the strategy outlined. One suggestion was the development of the Guam Growth Council.

The following three studies were completed as follow-ups to the 1975 Guam Economic Development Master Plan. They were done for the Guam Economic Development Authority by Overseas Bechtel, Inc. to define programs to help stimulate economic growth on Guam.

Program for Development of Apra Harbor; Overseas Bechtel, Incorporated; October, 1977. This study is a conceptual plan for the development of Apra Harbor that identifies some of the major land uses needed around the harbor after the U.S. Navy moves its ammunition loading and unloading wharf from Apra Harbor to Orote Point. The report contains a summary of the proposed development program, a description of the plan, a discussion of the present land uses around Apra Harbor, a discussion of the major industries that might require industrial sites, and a proposed development program for Apra Harbor and preliminary development schedule.

Program for Increasing Research and Development Activities on Guam; October, 1977; Overseas Bechtel, Incorporated. A review of Guam's potential for increasing R&D efforts, particularly with regard to U.S. Government programs. Ten candidate research projects in the fields of energy, marine sciences and agriculture, and their possible sources of funding are recommended. Elements for successful implementation of the research program are also discussed. Available: Bureau of Planning.

Program for Increasing U.S. Corporate Activities on Guam; Overseas Bechtel, Incorporated; November, 1977. The main purpose of this report is to outline a program that will encourage U.S. corporations to locate some of their regional administrative operations on Guam. Discussions also include advantages Guam can offer to U.S. corporations and the types of operations that could be logically located here.

# GENERAL ECONOMIC STUDIES AND DATA

Guam Needs Assessment; draft; Richard W. Miller, U.S. Department of Interior; February 24, 1978. A broad assessment of Guam's economic resources and development, fiscal system, and capital needs. Discussions of the economy include income; employment; wages; government, military, and private sectors; and zoning and land use. The tax system, expenditures, funds, autonomous agencies and capital development projects comprise discussions on the fiscal system. Capital needs include health, education, infrastructure, housing, and cultural facilities. Contains a compiliation of nearly 40 tables and charts.

Supplement of Economic Base Study for Territory of Guam, Mariana Islands; EDAW; prepared for the U. S. Army Corps of Engineers, Pacific Ocean Division; March 15, 1977. A partial statistical update of the Economic Base Study for the Territory of Guam, Mariana Islands, by the U.S. Army Corps of Engineers, May, 1973. The essential body of the report consists of a compilation of 27 tables. These show population; employment; sector analysis of tourism, construction, and military; land use; and socio-economic data; particularly for the southern subregion of Guam. The narrative consists of an analysis of the data which reflect changes Guam has undergone in the last four years, such as recent tourist related developments. Potentials for employment, housing, recreation, and agriculture related land uses focus on water development and storage facilities in the south.

Mid-Term Report and Recommendations on Government of Guam; January, 1976; issued by Senator Thomas V.C. Tanaka, Committee on Finance and Taxation; graphs, tables. An assessment of the economy with goals and recommendations for short- and intermediate-term solutions designed to provide positive policy guidance. The four major areas of concern discussed are economic recovery, budgeting, government organization, and taxes.

Guam Annual Economic Review 1976; Economic Research Center, Department of Commerce; April, 1977. The eighth annual overview of the island's economy. Consists of an analysis of capital improvements, utilities, military, Federal Disaster Assistance Administration, agriculture and fisheries, tourism and international trade, construction, manufacturing, financial institutions, personal income and cost of living, and labor. Contains 20 statistical tables and 10 figures.

Proceedings of the 7th Guam Annual Economic Conference "...towards a sound economic direction"; Guam Department of Commerce and Guam Chamber of Commerce; August 13, 1976; 73 pages. A compilation of addresses given during the conference which evaluate and recommend improvements in Guam's economic conditions, and formulate workable measures to counter the effects of future economic recessions. Discussions center on tourism; agriculture, mariculture and fisheries; and financial development.

South Pacific Economics: Statistical Summary; South Pacific Commission; September, 1977. A paper presented to the Regional Conference on Economic Development Planning, Suva, Fiji, October 24-28, 1977. Includes tables of selected economic indicators prepared by the SPC Economist and Assistant Economist with the assistance of the SPC Statistical Unit. 1) Population characteristics of Pacific countries. 2) Some estimates of national income and government expenditure. 3) Total and per capita trade. 4) Intraregional exports, 1975. 5) Percentage of population economically active. 6) Structural breakdown of economies as indicated by employment. Key Economic Indicators of the South Pacific, No. 1, December 1977; South Pacific Commission; March 1978. The first in a series of statistical publications presenting leading economic indicators for countries in the South Pacific region. Tables for Guam show: population, personal income, government expenditure, trade, gross business receipts, construction. international tourist travel, unemployment, finance and consumer price index. Bulletin of Statistics. Trust Territory of the Pacific Islands, Volume I, No. I: Office of Planning and Statistics, Office of the High Commissioner, Saipan, Mariana Islands; December, 1977. The statistical abstract of the Trust Territory and Northern Mariana Islands. Data does not include Guam; however it is interesting because it is the Trust Territory's first effort to compile and publish tables on population, employment, agriculture, manufacturing, tourism, education, health, and so forth. # TOPICAL ECONOMIC STUDIES AND DATA

Gross Island Product; Russell Krueger, Consultant, and Clara Okada, Department of Commerce; April, 1978. The purpose of this project is to estimate the income and product account of Guam from 1972 to 1977. The GIP is an extremely important tool in monitoring and regulating the state of the economy and in providing an economic accounting framework for long term development planning. It measures both the expenditures for consumption, government, investment and net international trade; and income generated by production, including employee compensation, profits, tax receipts, net interest, capital consumption allowance, and business transfer payments. The report is made up of more than 30 tables. These include: Gross Island Product, 1972-1976; Current and Constant GIP, 1972-1976; GIP by Quarter, 1972-1976, not seasonally adjusted; GIP by Quarter, 1972-1976, seasonally adjusted; Gross Business Receipts, 1973-1976; Personal Consumption Expenditures Components, 1972-1976; Government Expenditures - GIP Basis, 1972-1976; GovGuam Expenditures -GIP Basis, 1972-1976; Major Components of Net Exports, 1972-1976; Quarterly Military Personnel and Dependents on Guam. The report includes a detailed methodology suitable to allow preparation of similar estimates on an ongoing basis.

Guam Public Market Feasibility Study, The Prospect of Agriculture on Guam U.S.A.; Hong K. Sohn, prepared for the Guam Department of Commerce; July, 1977. A study to determine whether a public market can serve Guam's agriculture and cottage industry marketing needs. Conclusions and recommendations are based on an overall conceptual framework including examination of historical trends, identification of market function, delineation of marketing flow, and forecast of quantitative trends. A comprehensive examination of the entire system of the agrarian sector such as the number and types of producers, capital and labor constraints and potential for future output was conducted to estimate the amount of product flow through the public market. Demand for public market commodities was projected through 1979. Finally, possible location, design, methods of operation, and other specific aspects of implementation are discussed. Other policy recommendations for furthering Guam's Green Revolution are also proposed.

A Request to Reinstate Funds in the FY 1979 Defense Budget for Relocating the Navy Ammunition Wharf on Guam: Ammunition Wharf Task Force: February 27, 1978. The Government of Guam's position paper relating to the U.S. Government's decision to delay relocating the ammunition wharf to Orote Point. The paper includes discussion of the history of the wharf and efforts to relocate it, and the importance of Apra Harbor to Guam's economic development. Two draft reports were previously prepared: "Need for Relocation of the Ammunition Wharf," by the Bureau of Planning, and "Vulnerability Assessment and Economic Impact Scenario for a Large Scale Munitions Detonation of Hotel Wharf, Apra Harbor, Guam," by Michael Storch, Chamber of Commerce. Report of the Special Study Commission of the Guam Supertanker Port to the Fourteenth Guam Legislature; February, 1978. An initial effort toward studying the feasibility of Guam as a central terminal station storage facility (CTS). The report includes determination of the need for a central fuel storage facility among major oil-consuming nations (especially Japan), an analysis of transportation economic variables to assess economic feasibility, and an assessment of the capability of Guam and its desire to support such a facility. Statements of the methodology and procedures used are given. The report also contains a summary and analysis of the Palau Superport Project and its current status. Available: Bureau of Planning, Chief Planner's Office.

Guam Monthly Food Index; Cost of Living Office, Economic Research Center, Department of Commerce. A supplement of the Quarterly Report of the Guam Consumer Price Index published for the convenience of those who need the information as soon as possible. It consists of two tables: Monthly Food Index and Estimated Average Retail Food Prices. Available: Department of Commerce.

Guam Trade: Summary of Imports and Exports by Countries, Fiscal Year 1975;
4th Occasional Paper, Economic Research Center, Department of Commerce;
July, 1976. Compilation of nine tables showing import and export data by
country and cost in freight dollar value. Included are annual, quarterly
and monthly totals and percents of imports and exports by method of transport.

U.S. Census of Outlying Areas, 1972, Guam: Censuses of Construction Industries, Manufacturing, Wholesale Trade, Retail Trade, and Selected Service Industries; issued March, 1975. The economic censuses constitute comprehensive and periodic canvasses of the industrial and business activities in Guam. Data is presented by kind of business for construction industries, manufacturers, retail trade, wholesale trade, and selected service industries. Censuses were conducted in 1958, 1963, and 1967. Beginning in 1967, Congress authorezed the economic censuses to be taken at 5-year intervals covering years ending in "2" and "7".

# GOVERNMENT OF GUAM ECONOMIC ACTIVITY

Guam, A New Era of Growth: A Report to the People of Guam; Ricardo J. Bordallo, Governor of Guam; February 6, 1978. The Governor's Annual Message on the State of the Territory. Discusses factors accounting for improvements in Guam's socio-economic situation during the past year and goals for 1978. Contains some statistical and financial information. Available: Bureau of Planning, Chief Planner's Office.

Guam Rehabilitation Act Debt Study; Bureau of Planning; November, 1977; tables, graph. A study of the feasibility of a request for the forgiveness of a debt owed by the Government of Guam to the U.S. Treasury. The debt was incurred as the result of Congressional desire to rehabilitate Guam following World War II, and the implementation of Public Law 88-170, known as the Guam Rehabilitation Act of 1963. The report includes discussions of the Government of Guam's financial status, general fund revenues, and capital needs.

Guam: The United States Developing Territory--1977; Office of the Governor; January, 1977; 38 pages. A summary of federal fund grant and loan requirements necessary to meet Guam's community and economic development objectives. Proposed financing is detailed for the following capital improvement projects: post-Typhoon Pamela upgrade and restoration, government operations, rehabilitation and economic development, and community development. Eighteen statistical tables on the employment and unemployment record were compiled by the Bureau of Labor Statistics.

A compilation of data on the state of agricultural development in Guam and Micronesia. An assessment was made to determine future projects and/or programs that various government agencies will be undertaking. Another section discusses the situation on Guam: geography and climate; geology and vegetation; population and economy; agriculture; and potentials of fruit, vegetable, poultry, pork and fishery production. Discussions and recommendations follow. An appendix contains statistical tables on production and imports of selected commodities on Guam for various years until 1974.

The main purpose of the visit was to identify possible areas of research on economic aspects of agriculture which the University of Guam, specifically the College of Agriculture and Business, could carry out as part of its contribution to the Government's efforts to stimulate agricultural development. The report examines the present agricultural situation, support services for farmers, some gaps in present agricultural services, and economic research in agriculture, with suggestions and recommendations.

Conservation of Unique Farmlands; U.S. Air Force; August 19, 1977; 10 pages. An evaluation by the Guam Department of Land Management and other government agencies to determine if potential farmland sites exist on AAFB in order to conserve them and regulate encroachment on them. The report is an interim appraisal pending a more comprehensive analysis by the U.S. Department of Agriculture, Soil Conservation Service. When complete, it will be included in the Base Comprehensive Plan and the Base Land Management Plan.

An important feature of this study is that, for the first time, the impact of anticipated military expenditures on future tax revenues can be estimated. The report stresses that although the forecasts are the best estimates with the available data, they should be revised and extended when more current data becomes available.

A study to determine the availability of surface waters of the Ugam River to supply the needs of the southern districts of Yona, Talofofo, Inarajan, Merizo, Umatac and Agat in the year 2040. The scope of the study includes the selection of a dam site with sufficient storage capacity to supplement the low natural flows that would occur during a 20-year recurrence interval drought. Plan of Study, Ugam River, Territory of Guam; U.S. Department of the Army, Pacific Ocean Division, Corps of Engineers; April, 1977. Guam has petitioned to be designated under Section 1424(e) of the Safe Drinking Water Act which states that financial assistance may be denied for any project that may contaminate the aquifier. This report is a letter from GEPA to the Governor of Guam requesting a reevaluation of the petition and presents three alternatives with pros and cons for each; that is continuing with the petition, withdrawing the petition, or requesting further input from selected GovGuam agencies. Health Information System; Guam Health Planning and Development Agency. The Health Information System established in 1976 is no longer being utilized by the Department of Public Health and Social Services. Currently, Touche and Ross Company is being contracted by the Guam Health Planning and Development Agency to design another information system. When the program is implemented, it will provide for identification, collection and computerization of health data from all island physicians, clinics and hospitals, both government and private.

# MISCELLANEOUS PUBLISHED AND UNPUBLISHED REPORTS

Health Services for the Territory of Guam; Touche Ross & Co.; September, 1977. A study of all hospital-based programs and services which identifies civilian health care needs through 1990. The focus of the report is on three alternate ways of satisfying those needs in terms of hospital configuration, ownership, management and cost at GMH and MCM. The study is divided into two parts: Part One summarizes projections of needs and analyzes the alternative delivery structures; Part Two, the appendix, presents detailed information to support the analyses and conclusions, and describes the development of projections. Locally, Litigo and Bodig are of concern. The research team obtained water samples from 39 streams, springs, wells, and distribution systems which were

analyzed for amounts of 12 heavy metals plus manganese and calcium. Following initial analysis in the GEPA laboratory, the samples were taken to Japan for special analysis with sophisticated scientific instruments. This report shows tentative impressions; final results have not yet been published by the authors.

Guam Hospital Facilities Report for Governor Ricardo J. Bordallo and Lt. Governor Rudolfo Sablan; Submitted by Guam Memorial Hospital Board of Trustees; January 20, 1975, 8 pages. The report addresses itself to the question of the feasibility of the Government of Guam purchasing the Medical Center of the Marianas building and making it the central facility for major medical services. In making its recommendation, six tables show population served, hospital bed utilization, maximum and minumum medical service requirements for 1980 and 1985, and capital cost. The Board concluded that the purchase of MCM is a possible, but not a desirable solution.

It consists of the following sections: Crime and Justice in Guam-1976, a description of the existing criminal justice system and available resources that deal with crime problems, an annual and multi-year action plan, and special requirements of the grant. The Crime and Justice section has been published as a separate report and is described below.

Guam Crime Analysis 1975; February, 1977; Territorial Crime Commission; 77 pages. This report represents the first attempt by the Territorial Crime Commission to publish a relatively detailed statistical look at the crime situation on Guam. It was compiled to serve as the crime analysis section of the 1977 State Plan submitted to the Law Enforcement Assistance Administration. Data is taken from Department of Public Safety activity blotters and Summary Uniform Crime Reports, and, therefore focuses mainly on the police, excluding other units of the criminal justice system. Thirteen tables and 37 figures show data for crime in general, personal crime, property crime, miscellaneous Part II offenses, arrest data, and flow through the system of police and courts. A brief summary of socio-demographic/economic factors is also included. Available: Bureau of Planning Library.

Crime and Justice, Guam 1976; Territorial Crime Commission; July, 1977; 48 tables, 32 figures. The second annual report published by the TCC providing an analysis and statistical overview of crime and Guam's response to it. It is a part of the 1978 State Plan. Data was drawn from Uniform Crime Report figures of the Department of Public Safety and the annual statistical reports and activity logs of the relevant agencies. It should reflect a more accurate view of the crime and justice system on Guam than the Guam Crime Analysis-1975. The report also places increased emphasis on the criminal justice system and its performance. The report is divided into three main sections: the crime analysis, which corresponds, for the most part, with Guam Crime Analysis-1975; the system analysis, which presents data on performance of the criminal justice system on Guam, characteristics of clients and the agencies, and comparison with mainland norms; and the problem analysis, where the data previously presented is analyzed into a series of problem statements. Socio-economic and other ancillary data are also covered as separate sections. Available: Bureau of Planning Library.

Criminal Investigation Study; Pacific Studies Institute; March, 1978; prepared for the Guam Territorial Crime Commission. A study of the personal and household crime situation on Guam based on a survey of the extent of victimization including assault, larcency, burglary, auto theft, and robbery. Information on living patterns and the general attitudes of people towards crime, the criminal justice system and the Crime Prevention Mobil Unit Program conducted in 1976 was obtained in order to provide a data base for a demographic and socio-economic understanding of crime. A Report on Drug Abuse and Guam's Response; Territorial Crime Commission; December, 1977; 9 pages, 2 figures, 8 tables. Information concerning the extent and nature of the drug problem on Guam with a special emphasis on its relation to the convict population. The report consists of a compilation of data that was readily available from various government agencies and a brief analysis of it. There is currently very little drug related data available. Tables and figures included in the report are: six-year trend in actual reported narcotics offense rates on Guam with a three-year projection, marijuana and opiates seizures at Guam's ports of entry, age adjusted arrest rates for narcotics arrests-1976, percent distribution of narcotic offense arrestees by offense--Guam 1976, ethnic specific adjusted arrest rates, comparison of actual reported offenses/arrest/clearance narcotic offenses-Guam 1976, number of inmates reporting use of controlled substance by type of drug, inmates survey responses by offense and type of response, dollar value of heroin confiscated by Department of Public Safety, and statistical figure of drugs seized at ports of entry.

Draft Conceptual Design of the Guam Criminal Justice Information Management System; Arthur Young and Company; September, 1977; prepared for the Guam Department of Public Safety. A description of a design for an automated criminal justice information system which would provide for collection, storage, and dissemination of information required by the various criminal justice agencies of Guam to support planning, operation, and evaluative functions. The report consists of detailed discussions of each of the five major subsystems: Police Information, Subject-in-Process/OBTS, Support, Court Calendaring and Attorney General PROMIS. Estimated cost and benefits are included. Three appendices discuss systems considered for potential transfer, summary of data processing resource requirements to support the proposed system, and a data element requirements list.

## DEPARTMENT OF PUBLIC SAFETY SOURCE DOCUMENTS

One additional form has been added to the previous eight standard forms used in reporting most offenses.

Incident Report (DPS-1A). This form contains the same information as Incident Report (DPS-1) and is used when the complainant wishes to waive the complaint. It is filled out by the police officer and signed by the complainant.

Department of Public Safety Report of Alcohol Influence. This report is filled out by a police officer in the event of a motor vehicle accident, violation, or arrest involving alcohol. It includes: questions asked the subject about his health and recent alcohol drinking; observations by the police officer on the subject's appearance and behavior; police officer's conclusions as to the effects of alcohol on the subject and his ability to drive; and a physician's report.

# SURVEYS AND PUBLISHED REPORTS

1977 Community Profile Study; Fourteenth Guam Legislature Planning and Research Bureau; August, 1977. Partial results of an island-wide survey of village needs and problems. The questionnaire was compiled by the legislature's Committee of Youth and Senior Citizens and fielded by members of the Summer Youth Employment Program. The survey sample consists of 6,500 households. Respondents were given two lists of 21 needs and 23 problems and asked to choose the five most important from each list. Responses are ranked in order of percent chosen overall and for each village. Respondent characteristics are currently being computerized for such things as age, sex, race, economic status, and household size.

Basic Development Goals for Guam; Bureau of Planning; July, 1976. An analysis of the community's response to the "Basic Development Goals Questionnaire" survey by the Bureau of Planning. The questionnaire consisted of 17 positive goal statements concerning employment/manpower, land use, political status, consumer protection, transportation, natural resources, public revenue/expenditures, cultural heritage, economy, population growth, equal opportunity, government operations, housing, health, education, and welfare. Respondents were asked to indicate their reaction to each goal statement by agreeing or disagreeing with it. The purpose of the survey was to measure public attitudes and was used in the Land Use Element of the Comprehensive Development Plan. Available: Bureau of Planning.

Social Baseline Study of the Territory of Guam; compiled by C. Christopher Ford, Jane Jennison-Nolan, and Marvin Montvel-Cohen, for the U.S. Army Corps of Engineers; 1976; 221 pages. A compilation and summary of socio-cultural data to assist planners in determining the potential impact of projects related to Guam's water resources. Includes a general assessment of data concerning land use and ownership, the family and community, government and civic activity, cultural resources, and education. Contains many tables. The data is summarized in terms of five geographic regions.

Socio-Cultural Aspects of Development in Guam and Micronesia; O. Ronald Haverlandt, C. Christopher Ford, and Marvin Montvel-Cohen of the University of Guam; prepared for the Asian Institute for Economic Development and Planning, a division of the United Nations; December, 1975; 150 pages, tables. An analysis of the relationship between socio-cultural factors and development in Guam and Micronesia. Three interrelated factors were used: resource parameters, political considerations, and cultural determinants.

Stateside Planning for Vocational Rehabilitation Services, Guam 1974-1979; Division of Vocational Rehabilitation; May, 1973. Results of a survey of the major health and social agencies undertaken for the purpose of estimating the size of the disabled population on Guam. Tables show the disabling condition, age, and sex of the disabled. The current figures were compared to data collected in 1968 for the same purpose. Projections of the agency caseload and activities for the years 1974-1979 were made based on the survey findings, current national

and community priorities and past service records. A final section appended to this report outlines agency accomplishments since 1968.

Vocational Rehabilitation, Fiscal Year 1977; Guam Department of Vocational Rehabilitation; 1977; 14 pages. A report on the activity of the Department of Vocational Rehabilitation for FY 1977 including a statement of purpose with description of programs available to the handicapped. Includes a list of facts and figures on persons rehabilitated.

Attitudes Toward Language Maintenance and Language Shift in the Guamanian Speech Community; George A. Riley; published in Pacific Asian Studies, Volume II, Numbers 1 and 2; November, 1977; page 112-125. An analysis of the change in language preference on Guam from Chamorro to English, plus a discussion of factors affecting social and cultural change in Guam. Methods and results are discussed.

Election Comparative Analysis Report, Guam-1976; Guam Election Commission; 155 pages. A compilation of election statistics by the Guam Election Commission. The report gives the total number of registered voters, the number by distict, and the number of votes received by each candidate. An extensive statistical abstract chapter shows the voting record in general, and for primary and gubernatorial elections, with tables and graphs by election district from 1950 to 1974. ### LAND TRANSPORTATION

A Bicycling Program for Guam; Department of Public Works; August, 1976; 115 pages, tables, figures. A comprehensive bicycling plan to encourage safe bicycling on Guam. The overall program encompasses the education of the public, the enforcement of safe highway riding techniques, and the engineering of safe bikeways.

Proposed Street and Highway Program Territory of Guam, 1972-1977; Department of Public Works; June 24, 1971. A list of proposed yearly highway projects with maps. A chart shows the number of vehicle registration for each year from 1961 to 1970.

Accident data is collected by the Department of Public Safety. DPS police accident reports are used as source data for the computerization of the data. Data is computerized including 1974 and will soon be current. The Department of Public Safety and the Department of Public Works are both interested in accident analysis and each publish their own annual and monthly reports. The last annual reports are for 1976 and monthly reports are current until May, or June, 1977. Information contained in these reports is described below:

Accident Analysis Report; Department of Public Works Planning Division.

Semi-annual and annual report for 1976. The semi-annual accident summaries consist of the same tables shown in the 1976 Inventory of Planning Information Detail Section, compiled for six-month periods. The annual report has a similar accident summary for the year, plus 16 tables of motor vehicle crash facts including: number of registered motor vehicles, 1970-1976; number of licensed drivers, 1970-1976; number of vehicular miles traveled, 1972-1976; fatality rate per hundred thousand registered vehicles, 1970-1976; and so forth. Maps of accident locations are also given. Available: Bureau of Planning Library.

The following seven reports are compiled monthly by Department of Public Safety. The annual report is a summary of the monthly reports:

Summary of Accidents and Violations Report; Department of Public Safety. A monthly report of the total number of accidents and violations for the month, the previous month, the year to date, comparisons of the same period from the previous two years and monetary loss. Listed are: number of traffic accidents with no injury, injury and death; number of non-traffic accidents; number of traffic deaths; number of injuries; number of vehicles involved; number of vehicles damaged; number of hazardous violations; and number of non-hazardous violations.

Monthly Accident Report; Department of Public Safety. Monthly listing of the number of traffic accidents: no injury, injury, and death; non-traffic accidents; traffic deaths; persons injured; and total traffic accidents. Shows each month of the year and total.

<u>Monthly listing of accidents for the month and compared to the same month for the previous two years showing: types of accidents, types of vehicles, age of drivers, nationality of drivers and sex of drivers.</u>

Type of Traffic Accident Report; Department of Public Safety. Monthly listing of the types of accidents: auto-overturned, auto-auto-non-collision, auto-pedestrian, auto-pedacyclist, auto-motorcycle and scooter, auto-bicycle, auto-animal, auto-fixed object, motorcycle spilled, and more than two vehicle collision. Shows each month of the year and total.

Hazardous Violation Report; Department of Public Safety. Listing of violations for the month and compared to the same month for the previous two years for: speeding/imprudent, failed to yield, disobeyed stop sign, disregard stop sign, wrong lane, improper passing, following too close, improper start/turn/back, drunk driving, other improper driving, disobeyed traffic sign, and reckless driving.

Economic Losses Due to Deaths, Injuries and Vehicle Damage Report; Department of Public Safety. Listing of dollar losses for the month and compared to the same month for the previous two years based on an average of \$36,000 per death, \$2,400 per injury and \$380 per vehicle.

<u>Traffic Fatalities-to-Date Report</u>; Department of Public Safety. A monthly report of the number of fatalities by the hour of the day and the location (beat number) for the year-to-date.

### AIR TRANSPORTATION

Master Plan Guam International Air Terminal Draft Report Volumes I and II; Parsons Corporation, prepared for the Guam Airport Authority; July 22, 1977. An airport terminal complex master plan for Guam. Contains projections of future demands for the facilities and outlines a development program for GIAT. Stage I development focuses on new facilities needed to accommodate traffic to the year 1975. The "Ultimate Site" stage covers the period from 1985 onward until the available GIAT site is fully utilized. The report concentrates on a detailed plan for the first stage of facility development. Available: Bureau of Planning.

The color-key map is at a scale of 1:75,000.




